RESOLUTION NO. 05-533 1 2 WHEREAS, in Resolution No. 04-620, the Tohono O'odham Legislative Council accepted \$340,085 3 in new funding for the continuation of the Indian Environmental General Assistance 4 Program (GAP); and 5 WHEREAS, the GAP Grant project period extends from August 1, 2002 through July 31, 2006; and 6 WHEREAS, as part of a continuation grant, there remains a savings from the FY 2004 Budget 7 (\$43,949.55 needs to be included as part of the FY 2006 Budget); and 8 WHEREAS, the attached budget identifies where the savings amount of \$43,949.55 will be 9 allocated so that these funds may be expended during the FY 2006. 10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts 11 the savings budget in the amount of \$43,949.55 for the GAP Grant. 12 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that Tohono O'odham 13 Nation's Officials, to wit: the Chairwoman, Vice-Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any 14 15 amendments affecting the funding or funding level of the grant shall be submitted for 16 further prior approval. 17 BE IT FINALLY RESOLVED that the TONEPA is authorized to expend all available funds awarded 18 pursuant to Cooperative Agreement #GA-97924901-4 beginning August 1, 2002. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26^{TH} . Day 19 20 of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-AGAINST; <u>-0-</u> NOT VOTING; and <u>[01]</u> ABSENT, pursuant to the powers vested in the Council by 21 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the 22 23 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 24 25 18, 1934 (48 Stat. 984). 26 TOHONO O'ODHAM LEGISLATIVE COUNCIL 27 28 29 **30** Evelyn B.
