

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Savings of the Grant Award for the General Assistance Program (GAP) Grant)**

2 **WHEREAS, in Resolution No. 04-620, the Tohono O'odham Legislative Council accepted \$340,085**  
3 **in new funding for the continuation of the Indian Environmental General Assistance**  
4 **Program (GAP); and**

5 **WHEREAS, the GAP Grant project period extends from August 1, 2002 through July 31, 2006; and**

6 **WHEREAS, as part of a continuation grant, there remains a savings from the FY 2004 Budget**  
7 **(\$43,949.55 needs to be included as part of the FY 2006 Budget); and**

8 **WHEREAS, the attached budget identifies where the savings amount of \$43,949.55 will be**  
9 **allocated so that these funds may be expended during the FY 2006.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
11 **the savings budget in the amount of \$43,949.55 for the GAP Grant.**

12 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that Tohono O'odham**  
13 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman and any designated official**  
14 **are hereby authorized to negotiate and execute the grant, provided however, that any**  
15 **amendments affecting the funding or funding level of the grant shall be submitted for**  
16 **further prior approval.**

17 **BE IT FINALLY RESOLVED that the TONEPA is authorized to expend all available funds awarded**  
18 **pursuant to Cooperative Agreement #GA-97924901-4 beginning August 1, 2002.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup> Day**  
20 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**


