(Approval to Carry Forward to FY 06 the Allocation of Funds (\$6,566,396.12)
for the Westside Health Clinic Construction Budget)

RESOLUTION NO. 05-538

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 99-082 did accept and**
2 **support the proposed construction of the Westside Health Clinic in Joint Venture with**
3 **the Indian Health Services (I.H.S.); and**

4 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 04-655 did appropriate**
5 **funds for the design and construction (including Project Administration) of the**
6 **Westside Health Clinic in the amount of \$11,233,514; and**


7 **WHEREAS, the Westside Health Clinic is under construction with projected completion at end of**
8 **FY 2005.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **approve and authorize the carry forward in the amount of \$6,566,396.12 in accordance**
11 **with the Westside Health Clinic Construction Budget effective October 1, 2005 thru**
12 **September 30, 2006.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
15 **are authorized to negotiate and execute the budget, provided however, that any**
16 **amendments affecting the funds or funding levels of the budget shall be submitted for**
17 **further prior approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH Day**
19 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 1,931.95 FOR; -0-**
20 **AGAINST; 508.85 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


