1	WHEREAS, the Tohono O'odham Nation, upon enactment of Resolution No. 03-512, did accept a					
2	5-year grant, beginning October 1, 2003 to September 30, 2008, from the U.S.					
3	Department of Education, Rehabilitation Services Administration's Section 121					
4	(Vocational Rehabilitation Services Projects for American Indian with Disabilities)					
5	under P.L. 102-569 Rehabilitation Act of 1973 as amended; and					
6	WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will					
7	be provided to eligible enrolled members of the Tohono O'odham Nation and other					
8	federally recognized Native Americans living on the Nation with disabilities; and					
9	WHEREAS, the Tohono O'odham Nation, Department of Education will contribute the required					
10	10% match from the Education budget; and					
11	WHEREAS, the Vocational Rehabilitation Program has developed the FY 2006 budget in the					
12	amount of \$400,000.00 beginning October 1, 2005 through September 30, 2006 and is					
13	seeking approval of the attached budget.					
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby					
15	approves the Vocational Rehabilitation Program's FY 2006 budget in the amount of					
16	\$400,000.00 and hereby authorizes expenditure of the funds for the period of October					
17	1, 2005 through September 30, 2006.					
18	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham					
19	Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official					
20	are authorized to negotiate and execute the grant, provided however, that any					
21	amendments affecting the funds or funding levels of the grant shall be submitted for					
22	further prior approval.					
23	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $27^{\text{TH}}$ . Day					
24	of <u>SEPTEMBER, 2005</u> at a meeting at which a quorum was present with a vote of <u>2,440.80</u> FOR; <u>-0-</u>					
25	AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by					
26	Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the					
27	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant					
28	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June					
29	18, 1934 (48 Stat. 984).
