

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2006 Department of Health and Human Services Head Start Budgets)**

**RESOLUTION NO. 05-548**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**  
4 **Start Program to provide educational, health, mental health and parent involvement**  
5 **services to children, three to five years of age; and**

6 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
7 **budget as attached and incorporated by this reference, to be effective November 1,**  
8 **2005 through October 31, 2006 and request authorization to expend funds:**

- 9 1. **Head Start Administration Budget - \$148,423.86 + \$25,380.48 (IDC) = \$173,804.34,**
- 10 2. **Head Start Program Budget - \$1,231,790.49 + \$210,636.17 (IDC) = 1,442,426.66.**
- 11 3. **Head Start T & TA Budget - \$18,330.00 (IDC not in budget).**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **the above listed HeadStart Administration Budget, HeadStart Program Budget and the**  
14 **HeadStart T &TA Budget for the period November 1, 2005 through October 31, 2006.**

15 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Executive Branch to expend funds for the program listed herein above and as attached**  
17 **in the amount indicated, effective November 1, 2005 through October 31, 2006.**

- 18 1. **Head Start Administration Budget - \$148,423.86 + \$25,380.48 (IDC) = \$173,804.34,**
- 19 2. **Head Start Program Budget - \$1,231,790.49 + \$210,636.17 (IDC) = 1,442,426.66.**
- 20 3. **Head Start T & TA Budget - \$18,330.00 (IDC not in budget).**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**  
23 **are authorized to negotiate and execute the grant, provided however, that any**  
24 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
25 **further prior approval.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
27 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**


