

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorization to expend FY2005 Indian Health Service Memorandum of Agreement  
carryover funds for the Water Resources Study Program FY2006 budget 11-5016)**

**RESOLUTION NO. 05-552**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement**  
2 **(MOA) between the Water Resources Study Program and the Indian Health Service and**  
3 **the Indian Health Service MOA budget 11-5016 through Resolution 01-313; and**

4 **WHEREAS, the Water Resources Study Program has accumulated carryover funds in FY2005 in the**  
5 **amount of \$12,073.86, under the MOA; and**

6 **WHEREAS, the Water Resources Study Program budget 11-5016 has been reviewed by the Tohono**  
7 **O'odham Legislative Water Resources Committee and the Budget and Finance**  
8 **Committee and has been recommended to the Tohono O'odham Legislative Council**  
9 **for approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
11 **expenditure of FY2005 carryover funds in the amount of \$12,073.86 for the Water**  
12 **Resources Study Program FY2006 Indian Health Service MOA budget 11-5016, in**  
13 **accordance with the budget attached hereto.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**  
16 **are authorized to negotiate and execute the grant, provided however, that any**  
17 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
18 **further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
20 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (D) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
