14	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
15	Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official
16	are authorized to negotiate and execute the grant, provided however, that any
17	amendments affecting the funds or funding levels of the grant shall be submitted for
18	further prior approval.
