7	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the
8	expenditure of the APHIS grant in the amount of \$75,000 for the Agriculture Extension
9	Program FY2006 budget 14-1520, in accordance with the budget attached hereto.
10	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
11	O'odham Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated
12	official are authorized to negotiate and execute the grant, provided however, that any
13	amendments affecting the funds or funding levels of the grant shall be submitted for
14	further prior approval.
