**(Approval to Expend an Animal and Plant Health Inspection Service Grant Allocation**  
**for the Agriculture Extension Program FY2006 Budget 14-1520)**

1 **WHEREAS, the Agriculture Extension Program was awarded an Animal and Plant Health**  
2 **Inspection Service (APHIS) grant for veterinary services in the amount of \$75,000.00;**  
3 **and**


4 **WHEREAS, the Agriculture Extension Program budget 14-1520 has been reviewed by the Tohono**  
5 **O'odham Legislative Agriculture Committee and the Budget and Finance Committee**  
6 **and has been recommended to the Tohono O'odham Legislative Council for approval.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
8 **expenditure of the APHIS grant in the amount of \$75,000 for the Agriculture Extension**  
9 **Program FY2006 budget 14-1520, in accordance with the budget attached hereto.**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
11 **O'odham Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated**  
12 **official are authorized to negotiate and execute the grant, provided however, that any**  
13 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
14 **further prior approval.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
16 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**




