

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to accept and expend the Environmental Protection Agency Safe Drinking
Water Act grant allocation for the Water Resources Study Program FY 2006 budget 000000)**

RESOLUTION NO. 05-562

1 **WHEREAS, the Water Resources Study Program was awarded an Environmental Protection**
2 **Agency (EPA) Safe Drinking Water Act, Source Water Assessment Program grant for**
3 **the protection of the Tohono O'odham Utility Authority public drinking system from**
4 **natural and man-made contamination, in the amount of \$80,000.00, from October 1,**
5 **2005 to September 30, 2006; and**

6 **WHEREAS, the Water Resources Study Program budget 00-0000 has been reviewed by the Tohono**
7 **O'odham Legislative Water Resources Committee and Budget and Finance Committee**
8 **and has been recommended to the Tohono O'odham Legislative Council for approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**
10 **acceptance and expenditure of the EPA Safe Drinking Water Act grant, in the amount**
11 **of \$80,000, from October 1, 2005 to September 30, 2006, for the Water Resources Study**
12 **Program FY2006 budget 00-0000, in accordance with the budget attached hereto.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
15 **are authorized to negotiate and execute the grant, provided however, that any**
16 **amendments affecting the funds or funding levels of the grant shall be submitted for**
17 **further prior approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
19 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
