RESOLUTION NO. 05-563

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child Care**
4 **Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Executive Branch developed and obtained committee approval of the following budget**
6 **as attached and incorporated by this reference, to be effective October 1, 2005 through**
7 **September 30, 2006 and requests authorization to expend funds for the FY 2006 Child Care**
8 **and Development Fund (CCDF) in the amount of \$987,079.00 in the following budgets:**

- 9 1. **FY 2006 CCDF Discretionary Administration - \$83,837.87 + \$14,336.28 (IDC)**

- 11 2. **FY 2006 CCDF Discretionary Program - \$244,341.78 + \$34,754.07 (IDC) =**

22 **approves the above-listed CCDF Discretionary Administration, CCDF Discretionary**
23 **Program, CCDF Mandatory Program, CCDF Mandatory Administration for period October**
24 **1, 2005 through September 30, 2006.**

25 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for the**
26 **program listed herein above and as attached in the amount indicated, effective October**
27 **1, 2005 through September 30, 2006 for the FY 2006 Child Care and Development Fund in**
28 **the amount of \$987,079.00 in the budgets:**

5 **approval.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
7 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
9 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
10 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**


