

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Arizona Reimbursable Budget: Child and Adult Care Food Program)

RESOLUTION NO. 05-564

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the State**
2 **of Arizona; and**

3 **WHEREAS, the Arizona Department of Education through the Child and Adult Care Food Program**
4 **Service Agreement provided reimbursement of funds for food costs incurred based on the**
5 **guidelines identified in the agreements; and**

6 **WHEREAS, the Executive Branch developed and obtained committee approval of the following budgets**
7 **as attached and incorporated by this reference, to be effective October 1, 2005 through**
8 **September 30, 2006 and request authorization to expend the funds:**

9 **1. Child and Adult Care Food Program - \$40,000**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **approves the Child and Adult Care Food Program FY 2006 budget and authorizes to expend**
12 **funds for the program listed herein and as attached in the amounts indicated, effective**
13 **October 1, 2005 through September 30, 2006:**

14 **1. Child and Adult Care Food Program - \$40,000**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official are**
17 **authorized to negotiate and execute the grant, provided however, that any amendments**
18 **affecting the funds or funding levels of the grant shall be submitted for further prior**
19 **approval.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
21 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
