

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Department of Information and Technology -**  
**FY 2006 Ramah Navajo Chapter Class Action Settlement Fund)**

**RESOLUTION NO. 05-565**

1 **WHEREAS, the Tohono O'odham Nation, through the Tohono O'odham Department of Information**  
2 **and Technology, supports the Nation's Information and Technology to ensure its**  
3 **integrity, availability and responsibility of the safekeeping of its existing technology**  
4 **investment; and**

5 **WHEREAS, in Resolution No. 04-616 it authorized the Department of Information and Technology to**  
6 **accept and expend these funds in accordance with the approved budget reviewed by**  
7 **the Executive Committee and the Legislative Council's Budget and Finance Committee;**  
8 **and**

9 **WHEREAS, it has been discussed, assessed and determined that the continued use of these funds are**  
10 **best served and will continue to benefit the needs of all Executive Branch programs**  
11 **through the Department of Information and Technology. The funds will allow the**  
12 **department to continue to employ and provide Information Technology Project**  
13 **Management, Systems Administration, Information Technology Purchasing,**  
14 **Administrative Management support and Technical support; and**

15 **WHEREAS, the funds necessary for salaries would be available from the carryover from the**  
16 **Department of Information and Technology (14-1021 - Ramah Navajo Chapter Class Action**  
17 **Settlement Fund), in the amount of \$122,423.20; and**

18 **WHEREAS, the Tohono O'odham Nation requests that the Tohono O'odham Legislative Council**  
19 **approve the carryover and expenditure of such monies with corresponding budget**  
20 **approved by the Legislative Council's Budget and Finance Committee.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
22 **approve and authorize the Executive Branch to expend funds for the Tohono O'odham**  
23 **Department of Information and Technology FY 2006 Ramah Navajo Chapter Class Action**  
24 **Settlement Fund attached, effective October 1, 2005 through September 30, 2006, in the**  
25 **amount of \$122,423.20, in accordance with the settlement agreement and inclusive of**  
26 **budget modifications throughout this period.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the Tohono**  
28 **O'odham Nation's officials to wit: the Chairwoman, Vice-Chairman and any designated**  
29 **Official is hereby authorized to negotiate, execute and expend the sum of \$122,423.20.**




