

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Department of Health and Human Services, Division of Family Assistance - FY06 Food Distribution Program Nutrition Education Funding Budget Account No. 11-1316)**

**RESOLUTION NO. 05-567**

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family Assistance**  
2 **Division, Food Distribution Program under an FY 2006 grant with the United States**  
3 **Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages (commodity**  
5 **foods) and nutrition education to eligible households through tailgate runs throughout the**  
6 **Nation and nearby towns; and**

7 **WHEREAS, nutrition education funds have been made available to the Tohono O'odham Nation for**  
8 **FY2006 through the USDA in the amount of \$1,939.00; and**

9 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**  
10 **Division, Food Distribution Program has submitted the FY 2006 Nutrition Education**  
11 **funding budget in the amount of \$1,939.00 for review and approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **and authorizes the FY 2006 Food Distribution Nutrition Education budget in the amount**  
14 **of \$1,939.00 and authorizes expenditures in accordance with the attached budget.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
16 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official are**  
17 **authorized to negotiate and execute the grant, provided however, that any amendments**  
18 **affecting the funds or funding levels of the grant shall be submitted for further prior**  
19 **approval.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
21 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**


