

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2006 Department of Health and Human Services Title IV-B Budgets)

RESOLUTION NO. 05-568

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division of**
4 **Child Welfare Services to intervene against child abuse and neglect and to promote safe**
5 **and stable families; and**

6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**
7 **through the P.L. 93-638 master contract, specifically the BIA Social Services budget for**
8 **child welfare services and the BIA ICWA budget for Family Preservation Program, as**
9 **authorized by both P.L. 93-638 and the Department of Health and Human Services; and**

10 **WHEREAS, the Executive Branch developed and obtained committee approval of the following budgets**
11 **as attached and incorporated by this reference, to be effective October 01, 2005 through**
12 **September 30, 2006 and request authorization to expend funds:**

13 **1. FY 2006 Title IV-B, Subpart 1 for \$130,319.00**

14 **2. FY 2006 Title IV-B, Subpart 2 for \$122,090.00**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve and authorize the Executive Branch to expend funds for the budgets attached,**
17 **effective October 1, 2005 through September 30, 2006, in the following amounts:**

18 **1. FY 2006 Title IV-B, Subpart 1 for \$130,319.00**

19 **2. FY 2006 Title IV-B, Subpart 2 for \$122,090.00**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official are**
22 **authorized to negotiate and execute the grant, provided however, that any amendments**
23 **affecting the funds or funding levels of the grant shall be submitted for further prior**
24 **approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
26 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
