7	WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the
8	name change of the <u>Community Based Diabetes Prevention Program</u> to the <u>Health</u> y
9	O'odham Promotion Program; and,
10	WHEREAS, by Resolution No. 04-287, the Tohono O'odham Legislative Council approved a
11	resolution of support for the above entitled application for funding; and
12	WHEREAS, this program is known as <i>Ihptak Ap' e dag</i> , or Well Heart; and
13	WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the
14	Fiscal Year 2006 base budget of \$397,100.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
16	approves the Division of Health Promotion Program CVD risk reduction (<i>Ihptak Ap</i>
17	<i>e dag</i>) program budget of \$397,100 for FY 2006.
18	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
19	Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official
20	are authorized to negotiate and execute the grant, provided however, that any
21	amendments affecting the funds or funding levels of the grant shall be submitted for
22	further prior approval.
