**RESOLUTION NO. 05-572**

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**  
2 **substance abuse and mental health services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application for the Targeted Capacity**  
4 **Expansion Project to Increase Early Intervention Services for adolescent ages 11-17**  
5 **and their families through Provision of the Model Program Brief Strategic Family**  
6 **Therapy; and**

7 **WHEREAS, the Notice of Award was received for Fiscal Year 2005 on October 1, 2004 in the amount**  
8 **of \$499,545.00 for the first year of a three-year grant, and approval received for**  
9 **continuation for Year Two; and**

10 **WHEREAS, of the total grant amount \$499,545.00 is restricted to 14.30% in indirect costs; and**

11 **WHEREAS, FY2006 Targeted Capacity Expansion Project to Increase Early Intervention Services**  
12 **for adolescent ages 11-17 and their families through Provision of the Model Program**  
13 **Brief Strategic Family Therapy grant and budget in the amount of \$499,545.00 for Year**  
14 **Two of the grant are hereby submitted for review and approval by the Tohono**  
15 **O'odham Legislative Council.**

16 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

17 **1. It hereby approves and authorizes expenditures in accordance with the FY 2006**  
18 **targeted Capacity Expansion Project to Increase Early Intervention Services for**  
19 **adolescent ages 11-17 and their families through Provision of the Model Program**  
20 **Brief Strategic Family Therapy and attached budget in the amount of \$499,545.00**  
21 **for the second year of a two-year grant, modified as follows.**

22 **2. Of the total grant amount \$499,545.00 is restricted to 14.30% in indirect costs.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**  
25 **are authorized to negotiate and execute the grant, provided however, that any**  
26 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
27 **further prior approval.**


