RESOLUTION NO. 05-573

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**
2 **substance abuse and mental health services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application for this project in August**
4 **2004; and**

5 **WHEREAS, the Safe and Bright Futures, Domestic Violence for Children and Adolescent Planning**
6 **Grant is a planning and design process for a comprehensive system that will reduce**
7 **violence against children, adolescents and provide direct service for the children,**
8 **adolescents, and their families; and**

9 **WHEREAS, the Notice of Award was received for Fiscal Year 2005 in the amount of \$75,000.00 for**
10 **the first year of a two-year grant; and**

11 **WHEREAS, the Safe and Bright Future, Domestic Violence for Children and Adolescents Planning**
12 **Grant and budget in the amount of \$75,000 for Year Two of the two-year grant are**
13 **hereby submitted for review and approval by the Tohono O'odham Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **and authorizes expenditures in accordance with the Department of Health and**
16 **Human Services, Division of Behavioral Health FY 2006 The Safe and Bright Future,**
17 **Domestic Violence for Children and Adolescent Planning Grant and attached budget**
18 **in the amount of \$75,000 for the second year of a two-year grant.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
21 **are authorized to negotiate and execute the grant, provided however, that any**
22 **amendments affecting the funds or funding levels of the grant shall be submitted for**
23 **further prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
25 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (1) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


