

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2006 DHHS - Division of Community Health /Tuberculosis Control
Services Program Budget)

RESOLUTION NO. 05-575

1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services Program**
2 **to help prevent the spread of the disease through community education, prevention,**
3 **early detection, comprehensive regimens and careful follow up with individuals; and**

4 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services**
5 **Program has been provided in part through supplemental funding sources; and**

6 **WHEREAS, the Division of Community Health - Tuberculosis Control Services desires to continue**
7 **the services it provides to TB susceptible patients; and**

8 **WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received funding**
9 **from the State of Arizona, Department of Health Services for its program; and**

10 **WHEREAS, a budget in the amount of \$20,000.00 is submitted for review and approval by the**
11 **Tohono O'odham Legislative Council oversight committees.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

13 **1. It hereby approves the funding of the Tohono O'odham Tuberculosis Control**
14 **Services Program from the State of Arizona Department of Health Services and**
15 **approves expenditures in accordance with the attached budget in the amount of**
16 **\$20,000.00.**

17 **2. That the duration of this contract shall be from July 01, 2004 and remain in effect**
18 **as long as the Arizona Department of Health Services agrees to fund the Tohono**
19 **O'odham Tuberculosis Control Services Program.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
22 **are authorized to negotiate and execute the grant, provided however, that any**
23 **amendments affecting the funds or funding levels of the grant shall be submitted for**
24 **further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
26 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**


