

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services-Division
of Child Welfare Services FY 2006 Phoenix Indian School Trust Fund Budget)**

RESOLUTION NO. 05-577

1 **WHEREAS, the Tohono O'odham Nation was notified in November 1999 by the Executive Director of the**
2 **Inter-Tribal Council of Arizona, Mr. John R. Lewis, that the Nation is scheduled to receive**
3 **its first distribution of the Arizona Inter-Tribal Trust Fund in the amount of \$400,000.00 in**
4 **December 1999 under Public Law 100-969, Arizona Inter-Tribal and Navajo Trust Fund; and**
5 **WHEREAS, by Resolution No. 2000-253 and Resolution No. 03-221, the Legislative Council approved**
6 **allocations for all \$400,000.00 of this first distribution to fund budgets of the Department**
7 **of Health and Human Services - Child Welfare Division; and**
8 **WHEREAS, the Nation was eligible to receive the second distribution of the Arizona Inter-Tribal Trust**
9 **Fund in the amount of \$400,000.00 for Fiscal Years 2005, 2006, and 2007; and**
10 **WHEREAS, the Department of Health and Human Services-Division of Child Welfare Services was**
11 **allocated one-third of the second distribution in the amount of \$133,333.33 for its Fiscal**
12 **Year 2005 Phoenix Indian School Trust Fund budget, approved by Resolution No. 04-642;**
13 **and**
14 **WHEREAS, by agreement with the Nation's Executive Office and the Department of Health and Human**
15 **Services, another \$133,333.33 of the second distribution of the Arizona Inter-Tribal Trust**
16 **Fund will be committed to continue funding the Fiscal Year 2006 budget of the Department**
17 **of Health and Human Services - Child Welfare Division, for the period of October 1, 2005 -**
18 **September 30, 2006.**
19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
20 **does hereby approve and authorize the Executive Branch to expend funds for the FY2006**
21 **Phoenix Indian School Trust Fund budget attached, effective October 1, 2005 through**
22 **September 30, 2006, in the amount of \$133,333.33 committed to continue funding the**
23 **budget of the Department of Health and Human Services - Child Welfare Division, inclusive**
24 **of budget modifications during this period.**
25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official are**
27 **authorized to negotiate and execute the grant, provided however, that any amendments**
28 **affecting the funds or funding levels of the grant shall be submitted for further prior**
29 **approval.**


