**RESOLUTION NO. 05-578**

1 **WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State of**  
2 **Arizona to provide Arizona Long Term Care Services (ALTCS) Case Management**  
3 **services to eligible enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has provided Arizona Long Term Care Services (ALTCS)**  
5 **case management services since June 1996 and is reimbursed from the State of**  
6 **Arizona for the services; and**

7 **WHEREAS, the attached Department of Health and Human Services-Division of Senior Services -**  
8 **Arizona Long Term Care Services (ALTCS) Program fiscal year 2006 budget of**  
9 **\$277,165.27 with the 2.5 percent employee salary adjustment has been prepared in**  
10 **accordance with the FY 2006 Budget Development Instructions; and**

11 **WHEREAS, all future Arizona Long Term Care Services (ALTCS) Program client reimbursement**  
12 **funds obtained by the Division of Senior Services shall be applied to the Arizona**  
13 **Long Term Care Services (ALTCS) base budget for current and future program**  
14 **operations.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
16 **approves:**

17 **1. The Department of Health and Human Services-Division of Senior Services -**  
18 **Arizona Long Term Care Services (ALTCS) Program fiscal year 2006 budget of**  
19 **\$277,165.27 which also includes the 2.5 percent salary adjustments.**

20 **2. All future Arizona Long Term Care Services (ALTCS) Program client**  
21 **reimbursement funds obtained by the Division of Senior Services shall be applied**  
22 **to the Arizona Long Term Care Services (ALTCS) Program base budget for current**  
23 **and future program operations.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated**  
26 **official are authorized to negotiate and execute the grant, provided however, that**  
27 **any amendments affecting the funds or funding levels of the grant shall be**  
28 **submitted for further prior approval.**


