

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services STEPS
to a Healthier US Grant, STEPS to a Healthier Arizona Initiative (October 1, 2005
- September 30, 2006))

RESOLUTION NO. 05-579

1 **WHEREAS, the Tohono O'odham Nation has applied, and been approved to receive, \$436,941 in**
2 **competitive funding from the Arizona Department of Health Services; and**

3 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**
6 **1997; and**

7 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved**
8 **the name change of the Community Based Diabetes Prevention Program to the**
9 **Healthy O'odham Promotion Program; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
11 **Fiscal Year 2006 base budget of \$436,941.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
13 **Division of Health Promotion Program STEPS program budget of \$436,941 for FY 2006.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
16 **are authorized to negotiate and execute the grant, provided however, that any**
17 **amendments affecting the funds or funding levels of the grant shall be submitted for**
18 **further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
20 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


