11	from general fund revenues to fund the Executive Branch Fiscal Year 2006 Budget as
12	presented and attached.
13	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
14	Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official
15	are authorized to negotiate and execute the budget, provided however, that any
16	amendments affecting the funds or funding levels of the budget shall be submitted for
17	further prior approval.
