10	Council of Tohono O'odham Nation have reviewed this budget and recommends its					
11	approval and adoption.

13	has reviewed and approved the Fiscal Year 2006 budget submitted by the Judicial

16	authorized to be expended from sources of funding approved by this Council for					
17	support of the Fiscal Year 2006 budget of the Tohono O'odham Judicial Branch.
