

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing Continued Operation of P.L. 93-638 Programs Until a New Master  
Contract with the Bureau of Indian Affairs is Signed)**

**RESOLUTION NO. 05-591**

1 **WHEREAS, the Tohono O'odham Nation (the "Nation") has negotiated a new Public Law 93-638**  
2 **master contract with the Bureau of Indian Affairs to replace the current Master**  
3 **Contract No. 1450CTH54T61071, which expires on September 30, 2005; and**

4 **WHEREAS, the parties are ready to sign the new master contract, but the Bureau of Indian Affairs**  
5 **Central Office has issued an order to all agencies to immediately cease signing all**  
6 **contracts, purchase orders and grants, including P.L. 93-638 contracts, for the**  
7 **remainder of FY 2005 (September 30, 2005); and**

8 **WHEREAS, the Papago Agency has requested clarification whether the order applies to the**  
9 **Nation's new master contract which does not obligate any funds at the time of signing;**  
10 **and**

11 **WHEREAS, if the Nation's programs which function under the P.L. 93-638 Master Contract are to**  
12 **continue operating after September 30, 2005, legislative authority must be granted in**  
13 **order to extend the existing contract and to allow programs to operate under their FY**  
14 **2006 approved budgets using Master Contract "savings" or, if no "savings" are**  
15 **available using the Nation's funds, until such time that the new master contract is**  
16 **signed.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **authorizes the Nation's programs which function under the Master Contract to**  
19 **continue operating under their FY 2006 approved budgets using Master Contract**  
20 **"savings" or, if no "savings" are available using the Nation's funds, until the new**  
21 **master contract is in place, and authorizes the Chairwoman of the Nation to extend**  
22 **the Bureau of Indian Affairs Master Contract No. 1450CTH54T61071 until such time**  
23 **that the new master contract is signed by both parties.**

24 **BE IT FURTHER RESOLVED that the authority granted herein will expire on October 31, 2005, or**  
25 **at the time that the new master contract is in place, whichever occurs first.**




