

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2006 Legislative Branch Budget)**

**RESOLUTION NO. 05-592**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**  
4 **funds shall be pursuant to appropriations or budgets"authorized by resolution or**  
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2));**  
6 **and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY 2006**  
8 **Budget; and**


9 **WHEREAS, the Legislative Branch administration has proposed a 2.5% compensation adjustment**  
10 **across the board for all Legislative Council representatives and Legislative Branch**  
11 **employees for FY 2006; and**

12 **WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY**  
13 **2006 Legislative Branch Budget.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
15 **the FY 2006 Legislative Branch Budget in the amount of \$2,376,326.76, including a 2.5%**  
16 **compensation adjustment for all Legislative Council representatives and Legislative**  
17 **Branch employees.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
20 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 1,864.4 FOR; 155.40**  
21 **AGAINST; 421.0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
23 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**




