1	WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive
2	control of the Tohono O'odham Nation and to appropriate these funds for the
3	benefit of the nation and its members" provided that "[a]ll expenditures of these
4	funds shall be pursuant to appropriations or budgets"authorized by resolution or
5	ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2));

7	WHEREAS, the Legislative Branch has prepared and submitted for review and approvalits FY 2006
8	Budget; and
9	WHEREAS, the Legislative Branch administration has proposed a 2.5% compensation adjustment
10	across the board for all Legislative Council representatives and Legislative Branch
11	employees for FY 2006; and
12	WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY
13	2006 Legislative Branch Budget.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
15	the FY 2006 Legislative Branch Budget in the amount of \$2,376,326.76, including a 2.5%
16	compensation adjustment for all Legislative Council representatives and Legislative
17	Branch employees.
