| 6 | WHEREAS, the Council has previously adopted a formula for distributing gaming revenues to the |
| 7 | fund the operations of the Nation and the Nation's 11 district governments ("Districts") |
| 8 | (Resolution No. 94-098, as revised); and |
| 9 | WHEREAS, pursuant to Resolution No. 05-424, the Legislative Council approved the FY 2006 |
| 10 | distribution of gaming revenues to the Districts by equal distribution, but did not |
| 11 | clearly identify the amount of the FY 2006 distribution; and |
| 12 | WHEREAS, the total amount of the initial FY 2006 allocation to the Districts is \$1,098,428.82 per |
| 13 | District ("FY 2006 Initial District Allocation"); and |
| 14 | WHEREAS, because the final District distribution numbers were not available at the time that |
| 15 | Resolution No. 05-424 was passed, the Resolution noted that the final FY 2006 |
| 16 | allocation to the Districts could vary from the amount in the FY 2006 Initial District |
| 17 | Allocation; and |
| 18 | WHEREAS, the Office of the Treasurer has now determined that the final FY 2006 allocation to |
| 19 | each District is \$11,367.91 ("FY 2006 Final District Allocation"). |
| 20 | WHEREAS, it is in the Nation's best interest to (1) expressly authorize distribution of the FY 2006 |
| 21 | Final District Allocation and (2) amend Resolution No. 05-424 to specifically identify |
| 22 | the amount of the FY 2006 Initial District Allocation. |
| 23 | NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council |
| 24 | hereby amends Resolution No. 05-424 to provide that the FY 2006 Initial District |
| 25 | Allocation to each of the Nation's Districts is \$1,098,428.82. |
