

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Fiscal Year 2006 Gu Achi District Budget)**

**RESOLUTION NO. 05-595**

1 **WHEREAS, the Tohono O'odham Legislative Council established a quorum at a special meeting**  
2 **on September 27, 2005; and**

3 **WHEREAS, the Tohono O'odham Nation officials have passed Resolution #04-323 "Approving the**  
4 **FY 2006 Projected Revenues" for a distribution formula to distribute funds to the**  
5 **Districts for equal distribution with an amount of \$1,098,428.82; and**

6 **WHEREAS, the Gu Achi District has held a special meeting on Sunday, September 25<sup>th</sup>, 2005 to**  
7 **address the issue of the needs in the District's communities; and**

8 **WHEREAS, the Gu Achi District passed Resolution # 0509-092 approving their Fiscal Year 2006**  
9 **budget at the Sunday, September 25<sup>th</sup>, 2005 Special Meeting; and**

10 **WHEREAS, the Gu Achi District proposed its Fiscal Year 2006 budget to the Legislative Council for**  
11 **approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the Fiscal Year 2006 Gu**  
13 **Achi District Budget (as attached) for:**

32 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
33 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat. 984).**


