

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Approving Continuing Operations of San Lucy District Pending Approval of the  
FY 2006 Budget)

RESOLUTION NO. 05-598

1 WHEREAS, the San Lucy District Council enacted Resolution No. SL 09-97-05 requesting for the  
2 Tohono O'odham Legislative Council to approve the continued operation of the  
3 district pending approval of its FY 2006 budget; and

4 WHEREAS, San Lucy District has identified sufficient funds to continue the district operations;  
5 and

6 WHEREAS, it would be in the best interest of San Lucy District to continue governmental  
7 functions pending approval of their FY 2006 Budget.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
9 approves San Lucy District's request to continue governmental functions pursuant  
10 to terms and conditions of the District's FY 2005 Budget pending approval of the San  
11 Lucy District FY 2006 budget.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>th</sup> Day  
13 of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).




