

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Continuing Resolution for the Chukut Kuk District FY 2005 Budget)**

RESOLUTION NO. 05-599

1 **WHEREAS, the Chukut Kuk District did meet on, Tuesday, September 20, 2005 in Vamori, Chukut**
2 **Kuk District, at which a quorum was present; and**

3 **WHEREAS, the Fiscal Year of 2005 is approaching the ending date of September 30, 2005; and,**
4 **WHEREAS, the Chukut Kuk District Council is requesting authorization for a Continuing**
5 **Resolution for the Fiscal Year 2005 Budget in order for District operations to continue**
6 **without interruption; and**

7 **WHEREAS, the Chukut Kuk District Council did support and affirm their request by District**
8 **Resolution No. 2005-47 attached hereto and incorporated herein by this reference;**
9 **and**

10 **WHEREAS, the District Budget will continue to operate at the FY 2005 approved spending levels**
11 **until the FY 2006 budget is approved; and**

12 **WHEREAS, there are sufficient funds in the FY 2005 budget to cover expenditures for an additional**
13 **60 days or until the FY 2006 Chukut Kuk District Budget is reviewed and authorized for**
14 **expenditure; and**

15 **WHEREAS, the proposed Continuing Resolution has been presented and reviewed by the Tohono**
16 **O'odham Legislative Council, Budget & Finance Committee and has been**
17 **recommended for approval.**

18 **NOW THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **Continuing Resolution for the Chukut Kuk District Budget for FY 2005 for an**
20 **additional 60 days or until the proposed FY 2006 budget is presented and approved for**
21 **expenditure by the Tohono O'odham Legislative Council.**

22 **BE FURTHER RESOLVED that there are sufficient funds in the FY 2005 budget to cover expenditures**
23 **for an additional 60 days or until the FY 2006 Chukut Kuk District Budget is reviewed**
24 **and authorized for expenditure.**

25 **BE IT FINALLY RESOLVED that the Chukut Kuk District is proposing to present the Chukut Kuk**
26 **District FY 2006 Budget to the Tohono O'odham Legislative Council during the**
27 **November 2005 General Session.**




