

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Continuing Resolution for FY - 2006 Budget for the Schuk Toak District)**

**RESOLUTION NO. 05-601**

1 **WHEREAS, the Schuk Toak District presents to the Tohono O'odham Nation Legislative Council**  
2 **a request for a Continuing Resolution; and**

3 **WHEREAS, the Schuk Toak District Council held their regular meeting on September 21, 2005,**  
4 **at which a quorum was present; and**

5 **WHEREAS, several communities within the Schuk Toak District have not completed their**  
6 **budgets for FY-06; and**

7 **WHEREAS, the Schuk Toak District is unable to complete its FY -2006 Budget to present in the**  
8 **October Legislative Session; and**

9 **WHEREAS, the Schuk Toak District Council allows a period of forty five (45) days for communities**  
10 **to complete their FY-06 Budget; and**

11 **WHEREAS, the Schuk Toak District has sufficient funds in its financial accounts with Wachovia**  
12 **Securities for continued operations.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **approves a continuing resolution for the Schuk Toak District at current levels for a**  
15 **period of forty five (45) days for final approval of the District FY-06 Budget.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>. Day**  
17 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**


