

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Continue San Xavier District Government Operations Pending
Approval of its FY 2005/2006 Budget)**

RESOLUTION NO. 05-602

1 **WHEREAS, the San Xavier District is unable to forward its FY 2005/2006 approved budget to the**
2 **Tohono O'odham Legislative Council (TOLC) before the end of the fiscal year; and**

3 **WHEREAS, it is in the best interest of the San Xavier District (District) to continue its fiscal year**
4 **operation pending the review and approval of its FY 2005/2006 budget by the District**
5 **and TOLC; and**

6 **WHEREAS, the District has sufficient funds in its treasury to cover all expenditures during this**
7 **interim period.**

8 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**
9 **the San Xavier District to continue to expend funds for its regular operation at the FY**
10 **2004/2005 level until its FY 2005/2006 budget has been reviewed and sanctioned by**
11 **the Tohono O'odham Legislative Council by November 30, 2005.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
13 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
14 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


