

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Matilda S. Juan to the Tohono O'odham Election Board)

RESOLUTION NO. 05-613

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint members
2 of the Tohono O'odham Election Board pursuant to Section 1(B) of Article II of
3 Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"), which
4 states, "Members of the Election Board shall be appointed by the Tohono O'odham
5 Council for terms of five years, or until their successors are appointed and qualified";
6 and

7 WHEREAS, the Election Ordinance further requires "that appointments to the board shall be
8 made in such a way and for such terms that their terms shall be staggered so that the
9 term of office of only one member will end in any single year."; and

10 WHEREAS, on July 31, 2005, Election Board Member Matilda S. Juan's term did expire; she
11 continues to serve as a Board member until her successor is appointed; and

12 WHEREAS, in compliance with the Election Ordinance, the Legislative Council has the authority
13 to appoint a successor who will complete the five-year Election Board term that will
14 expire July 31, 2010; and

15 WHEREAS, the Rules Committee, having legislative oversight of the Election Board, has
16 interviewed Matilda S. Juan, a qualified, bilingual member of the Nation to serve the
17 remainder of the term commencing August 2005 and ending July 31, 2010.

18 NOW, THEREFORE, BE IT RESOLVED, the Legislative Council hereby appoints Matilda S. Juan
19 as a member of the Election Board upon the effective date of this Resolution to
20 complete the five-year term ending July 31, 2010.)

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day
22 of OCTOBER, 2005 at a meeting at which a quorum was present with a vote of 1,614.05 FOR; 826.75
23 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
24 Section 1 (b)(g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984).
