

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Tohono O'odham Nation's Reburial Ceremony Budget - FY 06)**

**RESOLUTION NO. 05-624**

1 **WHEREAS, the Tohono O'odham Nation upholds and respects the Culture, Traditions and**  
2 **Heritage from the Ancestral Past; and**

3 **WHEREAS, the Tohono O'odham Legislative Council acknowledged that there is a need to**  
4 **provide funding to assist the Nation's Annual Reburial Ceremony which takes place**  
5 **in November of every year; and**

6 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 2000-275**  
7 **appropriating funds for the Cultural Center Museum; and**

8 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 03-487 establishing**  
9 **a budget of \$10,000 for the Reburial Ceremony in FY 04, taking the funding from the**  
10 **Cultural Center Museum Reserve; and**

11 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 04-530 approving that**  
12 **the remaining funds from FY 04 (\$7,140.70) be carried over to provide funding for the**  
13 **Nation's Reburial Ceremony in FY 05 and that any remaining funds from FY 05 be**  
14 **carried over and expended until exhausted.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**


- 16 **1. The Tohono O'odam Legislative Council approves the FY 06 Nation Annual**  
17 **Reburial Ceremony Budget of \$5,166.63 of remaining funds from the FY 05 carry**  
18 **over.**
- 19 **2. The Tohono O'odham Legislative Council approves and authorizes the**  
20 **expenditure of these funds according to the attached budget.**
- 21 **3. The Tohono O'odham Legislative Council approves that any remaining funds**  
22 **beyond FY 06 will be carried over to FY 07.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day**  
24 **of OCTOBER, 2005 at a meeting at which a quorum was present with a vote of 2,201.7 FOR; 239.1**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**




