

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Pisinemo District Budget)

RESOLUTION NO. 05-632

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 05-424 approved the FY**
2 **2006 distribution of Gaming Revenues by equal distribution to all the Districts of the**
3 **Nation; and**

4 **WHEREAS, the district distribution are to be disbursed on August 1st of each year to give the**
5 **districts an amount to use for budgeting purposes; and**

6 **WHEREAS, our allocation for this year is \$1,098,428.82 a draft budget was presented to all of the**
7 **four communities within the district for comments and recommendations; and**

8 **WHEREAS, some of the monies were set aside for Economic Development which the budget has**
9 **not been finalized but one will come forward on a later date.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Pisinemo District respectfully request the Tohono**
11 **O'odham Legislative Council to approve the Pisinemo District FY 2006 Budget as**
12 **follows:**

19 **BE IT FURTHER RESOLVED that Pisinemo District requests the Tohono O'odham Legislative**
20 **Council to endorse the Pisinemo District FY 2006 operations budget and to authorize**
21 **employee compensation adjustment retroactive to October 01, 2005.**

22 **BE IT FINALLY RESOLVED that the budget in the amount of \$191,461.10 for the Economic**
23 **Development will be brought forth to the Tohono O'odham Legislative Council on a**
24 **later date after approved by the Pisinemo District Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
26 **of OCTOBER, 2005 at a meeting at which a quorum was present with a vote of 2,356.3 FOR; -0-**
27 **AGAINST; 84.50 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
29 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
