3 WHEREAS, by Resolution 2005-09 Pisin Mo'o did present a budget to the Legislative Council in  
4 said amount of \$54,789.14; and


5 WHEREAS, the Legislative Council did approve the Pisin Mo'o District Mining Royalties Budget

12 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves the FY 2005  
13 Budget Carryover in the amount of \$54,005.46 into the FY 2006 and expenditure up to  
14 September 30, 2006.


15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day

17 AGAINST; 73.45 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
18 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
19 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
21 18, 1934 (48 Stat. 984).


