

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY 2006 Budget)

RESOLUTION NO. 05-635

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with all legislative powers**
2 **including fiscal powers to adopt, approve, and amend annual budgets and to**
3 **authorize the expenditure of funds; and**

4 **WHEREAS, the Nation's district councils can expend district funds pursuant to budgets**
5 **authorized under resolution of the district councils and approved by the Tohono**
6 **O'odham Legislative Council; and**

7 **WHEREAS, the San Lucy District Council by Resolution No. SL 09-97-05 requested from the**
8 **Tohono O'odham Legislative Council authorization to continue district operations**
9 **pending completion of the FY 2006 Budget; thereby the Tohono O'odham Legislative**
10 **Council enacted Resolution No. 05-598 authorizing continued operation of the**
11 **district; and**

12 **WHEREAS, the San Lucy District Council scheduled a public presentation of the district's budget**
13 **on 29 September, resulting in no changes to the budget; and**

14 **WHEREAS, San Lucy District has received its share of the gaming revenues allocated to each**
15 **district in the amount of \$1,109,796.73, combined with anticipate carry-over funds**
16 **of \$68,713.39 and monies from P.L. 99-503 in the amount of \$1,242,644.00 totaling**
17 **\$2,420,832.88 as the compilation of funds for the FY 2006 budget; and**

18 **WHEREAS, the San Lucy District Council is requesting of the Tohono O'odham Legislative Council**
19 **to approve the District's FY 2006 Budget.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
21 **the San Lucy District FY 2006 Budget in the amount of \$2,420,832.88 retro-active**
22 **to 1 October 2005.**

23 **BE IT FURTHER RESOLVED that funds consisting of:**

24 **Gaming Revenues \$1,109,796.73**

25 **Prior Year Savings \$ 68,392.15**

26 **P.L. 99-503 \$1,242,644.00,**

27 **are the combined revenues for the San Lucy District FY 2006 Budget.**

1 **BE IT FINALLY RESOLVED** that bi-weekly disbursement of P.L. 99-503 funds to be wire
2 transferred to the San Lucy District Stockmen Bank, Gila Bend Branch Account.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th Day
4 of OCTOBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
5 AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by
6 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
7 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
9 18, 1934 (48 Stat. 984).


