WHEREAS, the Tohono O'odham Nation Youth Council has reviewed and identified its proposed
FY-2006 Carry-Over Surplus Funds Budget in the amount of \$57,490.65;and
WHEREAS, the Tohono O'odham Legislative Council Human Resource Development Committee,
Rules Committee, and Budget and Finance Committee have reviewed the FY-2006
Carry-Over Surplus Funds Budget.
NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
approves and authorizes expenditure of the FY-2006 Tohono O'odham Nation Youth
Council Carry-Over Surplus Funds Budget in the amount of \$57,490.65, provided
however, that any amendments affecting the funds or funding levels of the budget
shall be submitted for further Legislative Council approval.
BE IT FINALLY RESOLVED that the Tohono O'odham Nation Youth Council shall be a division within
the Education Department until final approval of the Youth Council within the
Nation's governmental structure.

Day of <u>OCTOBER, 2005</u> at a meeting at which a quorum was present with a vote of <u>2,440.80</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[02]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (<u>d)(2) & (b)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
