

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving of FY-2006 Tohono O'odham Nation Youth Council Carry-Over
Surplus Funds Budget in the amount of \$57,490.65)

RESOLUTION NO. 05-639

1 **WHEREAS, the Tohono O'odham Nation Youth Council was established by Tohono O'odham**
2 **Legislative Council Resolution No. 95-216 for the purpose of serving as the official**
3 **voice of the Tohono O'odham Youth; and**

4 **WHEREAS, the Tohono O'odham Legislative Council, by Resolution No. 05-094, approved FY-2005**
5 **surplus funds to be used as carry-over funds for the Youth Council in FY 2006; and**

6 **WHEREAS, the Tohono O'odham Nation Youth Council has reviewed and identified its proposed**
7 **FY-2006 Carry-Over Surplus Funds Budget in the amount of \$57,490.65; and**

8 **WHEREAS, the Tohono O'odham Legislative Council Human Resource Development Committee,**
9 **Rules Committee, and Budget and Finance Committee have reviewed the FY-2006**
10 **Carry-Over Surplus Funds Budget.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves and authorizes expenditure of the FY-2006 Tohono O'odham Nation Youth**
13 **Council Carry-Over Surplus Funds Budget in the amount of \$57,490.65, provided**
14 **however, that any amendments affecting the funds or funding levels of the budget**
15 **shall be submitted for further Legislative Council approval.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Youth Council shall be a division within**
17 **the Education Department until final approval of the Youth Council within the**
18 **Nation's governmental structure.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
20 **of OCTOBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (d)(2) & (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
23 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
