

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Enrollment Resolution No. 98-083)**

RESOLUTION NO. 05-654

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(h); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides**
6 **that the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on June 3, 1987 the Legislative Council pursuant to Resolution No. 195-87, approved**
9 **Yolanda M. Contreras Roll No. 1841-GA-87 for membership in the Tohono O'odham**
10 **Nation; and**

11 **WHEREAS, on March 02, 1998 the Legislative Council pursuant to Resolution No. 98-083 approved**
12 **Yolanda M. Contreras Roll No. 3308-GA-98 for membership in the Tohono O'odham**
13 **Nation; and**

14 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
15 **and family tree, Yolanda M. Contreras listed with Roll No. 1841-GA-87 and 3308-GA-98**
16 **is the same individual; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filling of Applications*) provides that once a**
18 **number has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

22 **1. The Tohono O'odham Legislative Council approves a modification of Resolution**
23 **No. 98-083 as follows:**

24 **The Roll No. listed for Yolanda M. Contreras is changed to 1841-GA-87 to reflect**
25 **the number originally assigned to the application of Yolanda M. Contreras June**
26 **3, 1987 which was approved by this Council pursuant to Resolution No. 98-083.**

27 **2. The Enrollment Committee shall make the necessary changes in the records of**
28 **the Enrollment Office to incorporate the stated modification.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day
2 of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
3 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article
4 II and Article V, Section 2 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the
5 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat. 984).
