

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Enrollment Resolution No. 04-659)**

RESOLUTION NO. 05-656

1 **WHEREAS, The Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(h); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on February 9, 1998 the Legislative Council pursuant to Resolution No. 98-034,**
9 **approved Aaron Anthony Martinez Roll No. 3275-GA-97 for membership in the Tohono**
10 **O'odham Nation; and**

11 **WHEREAS, on December 6, 2004 the Legislative Council pursuant to Resolution No. 04-659**
12 **approved Aaron Anthony Martinez Roll No. 3683-GA-04 for membership in the Tohono**
13 **O'odham Nation; and**

14 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
15 **and family tree, Aaron Anthony Martinez listed with Roll No. 3275-GA-97 and 3683-GA-**
16 **04 is the same individual; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filling of Applications*) provides that once a**
18 **number has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

22 **1. The Tohono O'odham Legislative Council approves a modification Resolution**
23 **No. 04-659 as follows:**

24 **The Roll No. listed for Aaron Anthony Martinez is changed to 3275-GA-97 to**
25 **reflect the number originally assigned to the application of Aaron Anthony**
26 **Martinez February 9, 1998 which was approved by this Council pursuant to**
27 **Resolution No. 04-659.**

28 **2. The Enrollment Committee shall make the necessary changes in the records**
29 **of the Enrollment Office to incorporate the stated modification.**
