1 **WHEREAS, the authorized expenditure period for the Department of Health & Human Services**
2 **Native Employment Works is July 1, 2005 through June 30, 2006; and**

3 **WHEREAS, the Department of Health & Human Services – Native Employment Works Annual**
4 **Budget has been amended/modified #1, to reflect salaries 2.5% increase in all**
5 **personnel, Re-classification of positions Office Support Worker to Secretary,**
6 **Teachers Assistant to One Stop Coordinator and Program Manager to Program**
7 **Administrator with salary adjustment the combined amount of \$150,868.00.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
9 **approve the Employment & Training Annual Department of Health & Human Services**
10 **Native Employment Works Budget PY 2005 Amendment/Modification #1 in the**
11 **allocation amount of \$150,868.00.**

12 **BE IT FUTHER RESOLVED the 2.5% salary increase and program reclassifications are approved for**
13 **retro active payment effective 10/01/05.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**
16 **execute the contracts and plans, provided however, that any amendment affecting**
17 **the funding or funding levels of this contract shall be submitted for further prior**
18 **approval by the Tohono O'odham Nation Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
20 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
