

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and Approving a Basic Grant for the Venito Garcia Library and Archives**  
**from the Institute of Museum and Library Services for FY 06)**

RESOLUTION NO. 05-672

1 WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia  
2 Library and Archives, the library agency for the Tohono O'odham Nation; and

3 WHEREAS, the Venito Garcia Library and Archives is charged with library development for the  
4 Tohono O'odham Nation; and

5 WHEREAS, the Venito Garcia Library and Archives has received this grant annually since 2000  
6 from IMLS (Institute of Museum and Library Services, the primary library funding  
7 agency for the U.S. federal government) through its Native American Library Services  
8 division.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accept the Basic  
10 Grant from the IMLS for library services and supplies for the Venito Garcia Library  
11 and Archives for the amount of \$6,000 and approves and authorizes the use of these  
12 funds by the Venito Garcia Library and Archives, and waives indirect costs (a  
13 requirement of this grant), provided, however, that any amendments affecting the  
14 funds or funding levels of the budget shall be submitted for further Legislative  
15 Council approval.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day  
17 of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-  
18 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
19 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
20 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
22 Stat. 984).


