

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with Yoder & Langford, P.C.)

RESOLUTION NO. 05-673

1 **WHEREAS, by Resolution Nos. 05-075 and 05-313, the Tohono O'odham Legislative Council**
2 **approved an Attorney Contract with the law firm of Yoder & Langford, P.C. (the**
3 **"Attorney") as amended, for legal services related to the 401(K) Plan of the Tohono**
4 **O'odham Nation (the "Nation"), in the amount of \$7,250 for the period October 1, 2004**
5 **through September 30, 2005; and**

6 **WHEREAS, the Attorney Contract expired on September 30, 2005; and**

7 **WHEREAS, it is in the best interest of the Nation to continue representation by the Attorney; and**

8 **WHEREAS, the Human Resources Officer recommends an Attorney Contract with the Attorney in**
9 **the amount of \$7,500 for the period from October 1, 2005 through September 30, 2006;**
10 **and**

11 **WHEREAS, the 401(K) Trustee budget (01-3036-810) has sufficient funds for the Contract amount;**
12 **and**

13 **WHEREAS, the Human Resources Development Committee, the Domestic Affairs Committee and**
14 **the Budget and Finance Committee recommend approval by the Legislative Council**
15 **of the Attorney Contract.**

16 **NOW, THEREFORE BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**
18 **the law firm of Yoder & Langford, P.C., in the amount of \$7,500 for the period**
19 **from October 1, 2005 through September 30, 2006, and in the form attached**
20 **hereto.**
- 21 **2. Funding for the Attorney Contract shall be provided from the 401(K) Trustee**
22 **budget (Account No. 01-3036-810).**
- 23 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
24 **Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
26 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,037.2 FOR; -0-**
27 **AGAINST; 403.6 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
