

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Paul J. Matte III Relating to Indian Child
Welfare Act Proceedings in Maricopa County Juvenile Court)

RESOLUTION NO. 05-675

1 WHEREAS, pursuant to Legislative Council Resolution No. 04-551, the Tohono O'odham Nation
2 (the "Nation") entered into an Attorney Contract with Paul J. Matte III; and
3 WHEREAS, the Attorney Contract expired on September 30, 2005; and
4 WHEREAS, additional representation is required to adequately protect the interests of the
5 Nation in proceedings under the Indian Child Welfare Act which are pending in the
6 Maricopa County Juvenile Court; and
7 WHEREAS, the Attorney General recommends the engagement of Paul J. Matte III to continue
8 representation under an Attorney Contract in the amount of \$25,000 for Fiscal Year
9 2006, for the period October 1, 2005 to September 30, 2006; and
10 WHEREAS, the budget for the Office of Attorney General (01-1031-810) has sufficient funds for the
11 Contract amount; and
12 WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of the
13 Attorney Contract by the Legislative Council.

14 NOW, THEREFORE, BE IT RESOLVED THAT:

- 15 1. The Tohono O'odham Legislative Council approves the Attorney Contract with
16 Paul J. Matte III in the amount of \$25,000 for Fiscal Year 2006, for the period
17 October 1, 2005 to September 30, 2006, in the form attached hereto.
- 18 2. Funding for the Attorney Contract shall be provided from the budget of the Office
19 of Attorney General (01-1031-810).
- 20 3. The Chairwoman of the Nation is authorized and directed to execute the Attorney
21 Contract.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day
23 of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
24 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
25 Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
26 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
27 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
28 18, 1934 (48 Stat. 984).


