

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment/Modification #1 of the Consolidated Healthy O'odham Promotion**  
**Program FY 2006 Budget (October 1, 2005 – September 30, 2006))**

**RESOLUTION NO. 05-683**

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**  
2 **through FY 2009 with a base budget of \$1,929,827.00 with additional carryover**  
3 **funding of \$3,353,000.00; and**

4 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**  
5 **establishment of the Community Based Diabetes Prevention Program, funded by the**  
6 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**  
7 **1997; and**

8 **WHEREAS, by Resolution Number 98-150, the Tohono O'odham Legislative Council approved the**  
9 **establishment of the Data Improvement Program under the Special Diabetes**  
10 **Programs for Indians, authorized by the Balanced Budget Act of 1997; and**

11 **WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved**  
12 **the name change of the Community Based Diabetes Prevention Program to the**  
13 **Healthy O'odham Promotion Program; and**

14 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**  
15 **Fiscal Year 2006 base budget of \$1,929,827.00 and carryover funding of \$3,353,000.00,**  
16 **for a total of \$5,282,827.00 to be retroactive to October 1, 2005.**

17 **NOW, THEREFORE, BE IT RESOLVED; that the Tohono O'odham Legislative Council:**

- 18 **1. Approves the Division of Health Promotion Program Fiscal Year 2006 base**  
19 **budget of \$1,929,827.00 and carryover funding of \$3,353,000.00, for a total of**  
20 **\$5,282,827.00 to be retroactive to October 1, 2005.**
- 21 **2. Approves the additions of the Major Capital line item in the amount of**  
22 **\$550,000.00 and the Alteration and Renovations line item in the amount of**  
23 **\$800,000.00.**
- 24 **3. Approves the addition of 3 new Gym Attendant positions to be assigned to North**  
25 **Komelik HOPP center and 3 new Gym Attendant positions to be assigned to a**  
26 **future HOPP site.**
- 27 **4. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice**  
28 **Chairman and any designated Official are hereby authorized to negotiate and**  
29 **execute the grant and expend funds associated with this budget.**

7 **Stat. 984).**


