

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Title III Health Promotion and Case Management Services Budget)

RESOLUTION NO. 05-685

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the TODHHS Senior Services Title III Program is possible**
4 **in part by Title III of the Older Americans Act funds administered through the Inter**
5 **Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the Tohono O'odham Nation Title III Program was awarded funds to provide Health**
7 **Promotion and Case Management services; and**

8 **WHEREAS, the Division of Senior Services has prepared new budgets of \$4,837.00 for the Case**
9 **Management and \$17,698.00 for the Health Promotion to include Health Promotion,**
10 **Case Management, Information/Referral, Outreach and Training services under the**
11 **Title III Program.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **approves:**

- 14 **1. The new Division of Senior Services budgets of \$4,837.00 for Case Management**
15 **and \$17,698.00 for Health Promotion to include Health Promotion, Case**
16 **Management, Information/Referral, Outreach and Training services under the**
17 **Title III Program for period July 1, 2005 to June 30, 2006.**
- 18 **2. The Tohono O'odham Nation officials to wit, the Chairwoman is hereby authorized**
19 **to negotiate and execute the grant, provided however, that any amendments**
20 **affecting the funding or funding levels of this contract shall be submitted for**
21 **further prior approval by this Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH. Day**
23 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**


