

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2006-Title VI Nutrition Services Incentive Program Budget April 1, 2005 through**  
**March 31, 2006)**

**RESOLUTION NO. 05-686**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**  
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been possible in part**  
4 **by Title VI of the Older American's Act of 1978 as amended and the Administration on**  
5 **Aging, Nutrition Services Incentive Program (NSIP); and**

6 **WHEREAS, the Title VI Nutrition Services Incentive Program (NSIP) Grant Budget was prepared**  
7 **to utilize the Administration on Aging grant of \$7,983.00 to continue to provide**  
8 **nutrition services to eligible elders of the Nation.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 10           **1. That it hereby approves the Title VI Nutrition Services Incentive Program (NSIP)**  
11           **Budget utilizing the Administration on Aging grant of \$7,983.00, to maintain**  
12           **services as per attachments for period April 1, 2005 to March 31, 2006.**
- 13           **2. The Tohono O'odham Nation officials to wit: The Chairwoman is hereby**  
14           **authorized to negotiate and execute the grant, provided however, that any**  
15           **amendments affecting the funding levels of this contract shall be submitted for**  
16           **further approval by this Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup> Day**  
18 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
23 **Stat. 984).**
