

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2006 Title VI, Part A Program Budget Amendment 1)

RESOLUTION NO. 05-688

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the TODHHS Division of Senior Services Division is**
4 **possible in part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, on January 14, 2005 the Tohono O'odham Nation Legislative Council approved the**
6 **Title VI, Part-A Program fiscal year 2006 budget of \$179,810.00 with Resolution**
7 **No. 05-045; and**

8 **WHEREAS, the original Title VI Part-A Program budget has been *amended* to decrease from**
9 **\$179,810.00 to \$136,940.00 (Decrease of \$42,870.00) in accordance to the Grant Award**
10 **letter received after the approval of the \$179,810.00 budget.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves:**

- 13 1. **The fiscal year 2006 Division of Senior Services Title VI Part-A budget**
14 ***amendment* to decrease from \$179,810 to \$136,940.00 (Decrease of \$42,870.00).**
15 **The budget amendment is in accordance with the "Grant Award" letter received**
16 **after the approval of the \$179,810.00 budget for period April 1, 2005 to March 31,**
17 **2006.**
- 18 2. **The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby**
19 **authorized to negotiate and execute the grant, provided however, that any**
20 **amendments affecting the funding or funding levels of this contract shall be**
21 **submitted for further prior approval by this Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH Day**
23 **of NOVEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
